NOTICE OF PROPOSED ROAD ABANDONMENT

Notice is hereby given that the BOARD OF COUNTY ROAD COMMISSIONERS has received a Petition and is considering the absolute abandonment and discontinuance of a public highway pursuant to the provisions of Section 224.18 of Michigan Compiled Laws Act 283 of 1909 as amended.

Please be advised that if you or your agency or organization has any interest in the petitioned abandonment, this is your opportunity to be heard and/or to submit written statements to be made part of the record.

It is expected that a public hearing will not be necessary and the petition will be considered by the BOARD OF COUNTY ROAD COMMISSIONERS at a regular meeting on Monday, April 24, 2017. Any verbal statements on this abandonment may be made by telephone or in person to the Planning Department of the Monroe County Road Commission (Telephone No. 734-240-5102). Any written statements should be submitted to the Monroe County Road Commission at 840 S. Telegraph, Monroe, Michigan 48161 before Tuesday, April 18, 2017.

The County Road petitioned to be abandoned and discontinued is located in Monroe Township, and listed below.

Daisy Dell Drive

Located in Daisy Dell Place according to the plat thereof as recorded in Liber 6, Page 55 at the Monroe County Register of Deeds office, Monroe Township, Monroe County, Michigan, being part of Private Claim No. 498, that portion of Daisy Dell Drive between the northeast lot line of lot 8 extend to lot 35 and the southwest plat line of Daisy Dell Place, having a 60 foot right of way.

Cowell Drive

Located in Daisy Dell Place according to the plat thereof as recorded in Liber 6, Page 55 at the Monroe County Register of Deeds office, Monroe Township, Monroe County, Michigan, being part of Private Claim No. 498, Cowell Drive in its entirety, from the westerly line of said plat to the easterly line of said plat, having a 60 foot right of way.

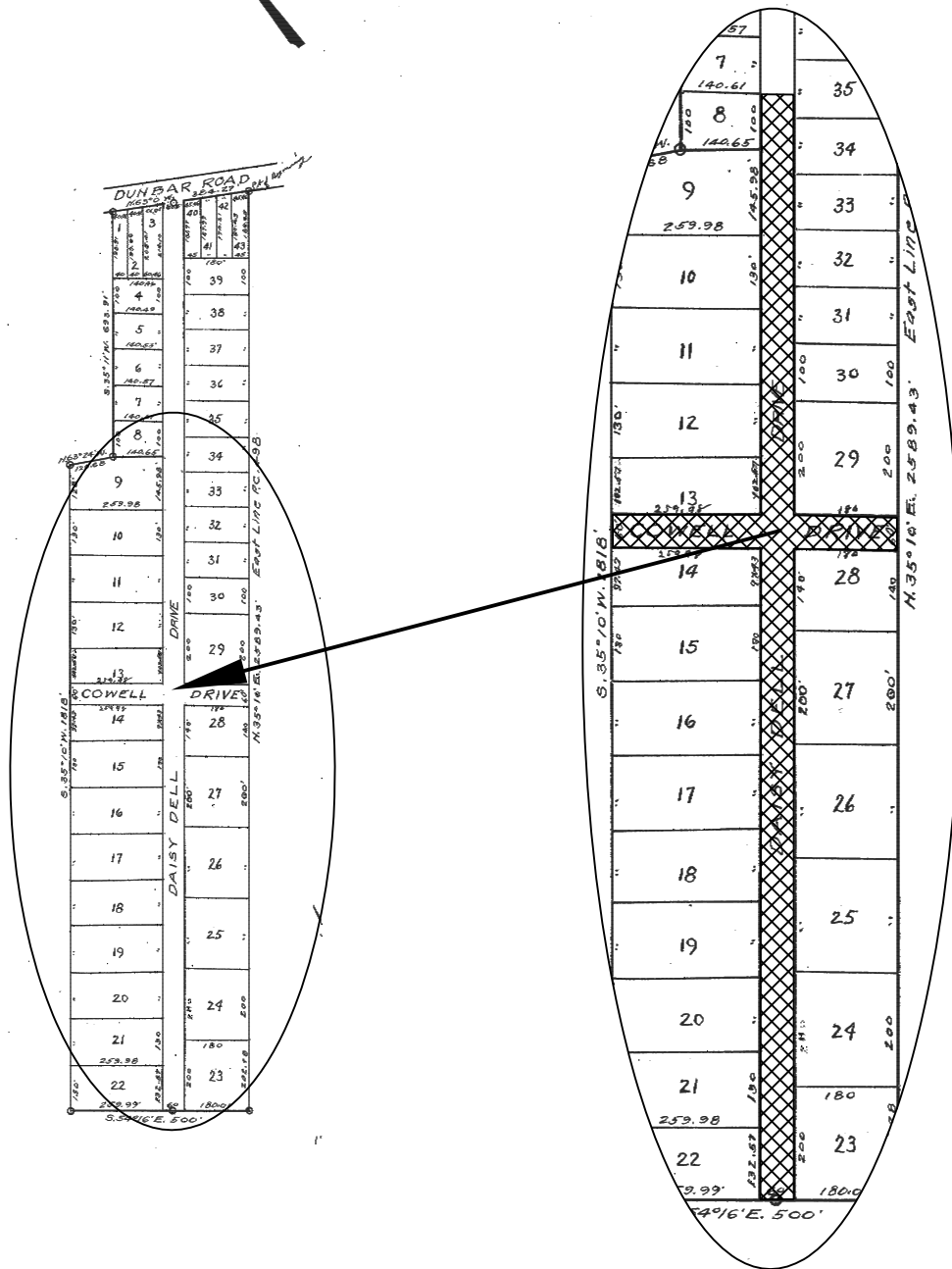
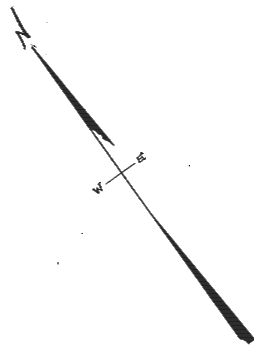
